These terms and conditions outline the rules and regulations for the use of Loopsic.

By accessing to the Service, we assume you accept these terms and conditions in full. You may not use Loopsic if you do not accept all of the terms and conditions stated on this page.

Basic Introduction

In order to use the service or access the content, you are agreeing to the following terms and conditions.

Loopsic does NOT claim ANY ownership rights in the images, photos, songs, works of authorship, or any other materials (collectively, "Content") that you use from Spotify® or Apple Music®, you are solely responsible for all the Content that you listen while using Loopsic.

It is your responsibility to make sure your use of the Services is legal where you use them. And you retain the rights to all the Content you created.

Privacy Policy

Protecting your privacy is important to us. We hope the following statement will help you understand how Loopsic deals with the personal identifiable information ('PII') you may occasionally provide to us via Internet.

Generally, we do not collect any PII from you when you download our iOS, Android applications. To be specific, we do not require the consumers to get registered before downloading the application, nor do we keep track of the consumers' visits of our application, we even don't have a Server to store such PII.

The only situation we may get access to your PII is when you personally decide to email us your feedback or to provide us with a bug report. Subscription Terms

1. Trial

2. Subscription

The subscription renews automatically at the end of each period (each month or 12 months depending on the option selected by you at the time of purchase) until you cancel.

3. Payment method

Payment will be charged to the registered payment method you submitted on your Apple ID or Google Play account at the billing configuration at confirmation of purchase. You authorize us to charge the applicable fees to the payment method that you submit.

4. Cancellation

Cancelling your subscription means that the automatic renewal will be disabled, but you will still have access to all your subscription features for the remaining time of then-current period. Note that deleting the app does not cancel your subscriptions.
